G3. CITY MANAGER'S REPORT (Informational Oral Presentation – not for Council action)

City Manager announced the following:

- 1) Angela Rushen is joining SCAG as the Manager of Media and Public Affairs; wished her all the best in her new position
- Made two operational changes which eliminated two executive level positions effective October 20: Assistant to the City Manager and Library Services Director
- 3) The Code & Neighborhood Services Division in cooperation with the PD POP Team conducted a sweep of illegal residential trash scavengers on September 29; two sweeps have been scheduled in the coming weeks
- 4) As part of City's foreclosure team efforts, 150 residential properties have been brought into compliance with City's property maintenance regulations; staff is working with responsible parties to achieve voluntary compliance
- 5) On October 18, the Art Commission will be holding its first Artober Fest at the Conference and Recreation Center
- 6) On October 25, the second annual Business Breakthrough event will be held at the Conference and Recreation Center this program is a partnership between the City, the Moreno Valley Chamber of Commerce and the Moreno Valley Hispanic Chamber of Commerce
- 7) The library will be closed to the public on October 28 and 29 as Riverside County implements a major upgrade to the library automation system

CLOSING COMMENTS AND/OR REPORTS OF THE CITY COUNCIL, COMMUNITY SERVICES DISTRICT, OR COMMUNITY REDEVELOPMENT AGENCY

Mayor Pro Tem West

- 1) During the last District 3 Crime Prevention Committee meeting, Deputy City Attorney Paul Early gave an outstanding presentation about code violations enforcement
- 2) Important election issues could change his District forever; the proposed huge distribution center could contribute to a significant increase in diesel truck trips and pollution; stated that residents of his District are against it
- 3) Commented on negative campaign flyers and large contributions from developers

Council Member White

- 1) Menifee is the 26th city in Western Riverside County; wished success on behalf of the Moreno Valley residents
- 2) The City has received a HUD allocation of over \$11 million for the neighborhood foreclosure stabilization; the City is working on the action plan that must be presented to HUD by December 1
- 3) Over the six months period ending in August, red light cameras at Frederick and Gateway have recorded 6,707 violations, and the recently installed cameras at Perris and Alessandro, 266 violations; cameras are catching violators
- 4) Unlicensed contractors are preying on homeowners. Building and Safety Department and California Contractors State License Board set up an operation to fair-out unlicensed contractors; several unlicensed contractors were arrested and issued citations
- 5) Last Tuesday, attended a ribbon cutting ceremony for Kia Motors, which relocated to Moreno Valley from Chino
- 6) Offered suggestions to relieve financial pressures and reduce operating cost
- 7) Commented on campaign flyers financed by his opponents and developers

Council Member Stewart

- Referred to his comments made during the last Council meeting regarding Middle School After School Sport Program – received a call from the Moreno Valley School District explaining the financial challenges and priorities; will try to find a way to keep this program going
- 2) Commented on political signs being placed on electric and wooden power poles it is against the law and it creates hazard for workers
- 3) Despite the overall economy slowing down, projects are still coming to Moreno Valley; new jobs are created
- 4) Commended outgoing Chief Rick Hall for changes he made in crime enforcement, including implementing zone policing, and attacking gang and burglary problem
- 5) Commented on campaign contributions/donations to candidates and incumbents
- 6) Utility tax supports general fund, police and fire; Proposition P is designed to lower the tax slightly and modernize the language to comply with the new laws

7) Emphasized the importance of cooperation between Council members to get the things done and of running the campaigns honestly

Mayor Batey

- 1) Commented on campaign contributions/donations
- 2) Supports Council Member White's recommendations for dealing with current financial situation
- 3) Thanked the Towngate Center and Pastor Triplett for organizing the fundraising car show for the cops and clergy; the event was very well attended
- 4) Thanked Council Member Stewart for his efforts to keep the after school sport program
