- 1. Each RTA bus route is examined whether it meets specific eight criteria, including the number of passengers per hour and the number of passengers per mile. Route No. 17, which runs from the Moreno Valley mall through the central part of the City to Super Wal-Mart on Moreno Beach Drive, has consistently failed to meet standard requirements. RTA staff recommended to completely discontinuing this route. RTA is seeking public input before reducing a service level. - 8) Commented on misinformation on Internet blogs

### Council Member Hastings

- 1) Last week, together with Council Member Molina, attended New Council Members and Mayors Institute in Sacramento the Institute provided very beneficial information and opportunity to network with other cities; the City of Grand Terrace is asking SANBAG for their support in financing improvements of the I-215 from Freeway 10 to Freeway 60, where residents experience very heavy traffic; asked the City Manager to provide a letter of support to the City of Grand Terrace; the letter will be submitted to SANBAG along with the request for funding; the project would be very beneficial to the residents of Moreno Valley and the residents of surrounding cities
- 2) Joined Mayor Pro Tem Flickinger in commending anyone serving on City Council advisory boards and commissions; it is an excellent way for anyone who wants to be involved and have input; urged residents to apply for current vacancies and be part of advisory body to the City Council
- 3) Regarding online blogs concurred with Mayor Pro Tem Flickinger that they contain misinformation and it's too difficult to respond to them because of the volume; asked to call her about any issue

### Council Member Molina
