- 3) Responded to a speaker comments regarding traffic enforcement stated that quotas are illegal in California and traffic enforcement officers using a radar can't distinguish between the races; traffic officers play an important role and we don't have enough traffic officers - majority of accidents can be prevented by having law enforcement officers present; more people are injured by accidents in the City than by burglars and robbers combined; many complaints against police officers are unfounded
- 4) Addressed issues raised by a speaker regarding staff's salaries most of the staff members making over \$100,000 are holding engineering degrees
- 5) Regarding CDBG funds allocation- stated that staff met with Council Members individually to discuss this issue before bringing the item to the Council meeting
- 6) Responded to Mr. Bleckert's comments given during March 10, 2009 City Council meeting regarding improvements of Ironwood and Perris intersection improvements are in progress
