G.7 CITY MANAGER'S REPORT (Informational Oral Presentation - not for Council action)

The City Manager reported the following:

- 1) The Animal Shelter is participating in the 2009 Iams "Home for the Holidays" pet adoption campaign that runs from October 1, 2009 to January 2010. Shelter staff along with volunteers will be featuring adoptable pets at the Southern California Fair at the Lake Perris Fairgrounds - pets will be on display on weekends of October 10 and October 17; other animal rescue organizations will be also involved in finding homes for pets;
- 2) The Police Department's POP Team arrested 18 suspects for graffiti vandalism who were responsible for over \$200,000 in damages to public and private property; six separate restitution requests were submitted for damages totaling nearly \$188,000;
- 3) The Code and Neighborhood Services Division has been awarded the Edward Byrne Memorial Justice Assistance Grant (JAG) that can be used for various enforcement needs, including the prosecution of offenders, crime prevention, and education of the community. The award in the amount of approximately \$106,000 will be used to hire two part-time officers to be deployed to address the proliferation of various code violations.
