The City Manager announced the following:

1) Commended staff for working in a timely and efficient manner on processing Highland Fairview development documents for Sketchers project; all the deadlines were met

2) Mayor Flickinger was elected vice-chair of RCTC Western Riverside County Programs and Projects Committee and also joined the board of directors of UCR Citizens University Committee

3) Today the Council received a draft copy of budget for the next year that reflects nearly \$17 million shortfall; the Council and staff are working hard to reduce this shortfall; about 5-6 public meetings will be held before budget adoptions; encouraged citizens to attend these meetings; Citizen's Guide to the Preliminary Operating Budget is posted on the Web site

4) Starting this week, City Manager's Update will be posted on the City's Web site; encouraged residents to view it periodically to find out what is going on in Moreno Valley

5) Four Foreclosure Prevention workshops will be conducted, one in each Council District; first one is scheduled on April 26 at Vista High Middle School in District 2; dates for workshops are listed on the Web site; video version is being taped and it will be shown on MVTV-3 for those who cannot attend

6) Burlington Coat Factory remains number 2 among stores recently opened; Frazee Paint Distribution Center is hoping to open this month; the newly opened Hampton Inn remains a top performing hotel across the country

9) A new program is being developed - Shop MoVal will feauture displays at kiosks, Press Enterprise, Your Villa magazine and with a more substantial presence on MVTV-3 and City's Web site

#### CLOSING COMMENTS AND/OR REPORTS OF THE CITY COUNCIL, COMMUNITY SERVICES DISTRICT, OR COMMUNITY REDEVELOPMENT AGENCY

#### Mayor Pro Tem Hastings

1) Responded to speaker's comments about budget - other government agencies, including the County, are facing budget deficits also; in addition, the State is looking into taking funds from the local governments; the budget picture doesn't look good, but local government needs to work efficiently to provide core services to the residents

 League of California Cities sponsored an initiative to protect local funds; encouraged everyone to vote on it; still working on retaining RDA funds; it is a very tough time right now, but tough times don't last, tough people do
Regarding Rancho Belago signs - expressed concerns about it while the City is facing a budget deficit

4) A very productive townhall meeting with two Homeowners Associations, staff and POP team was held at Moreno Valley Ranch - about 125 residents attended; thanked everybody who attended

#### Council Member Batey

1) Responded to speaker's comments regarding Edgemont District water issue - Box Spring Mutual Water District is a private, for profit company with own governing board and shareholders making decisions on water rates, maintenance and service; the District collects money and the District, not the City Council, is responsible for upgrades. According to the study, it will cost over \$15 million to upgrade and increase capacity of the system; the Council tried the best to partner with the board and provide seed money for improvements, but so far, not much has been done. It is a serious issue, as the lack of system improvements is holding other projects in that area.

A meeting with the major water districts, the County Supervisors' office and the City is set up at the end of May to develop a long term plan to bring necessary improvements; a lot of work needs to be done, and it will take about five to ten years to upgrade the system

2) Regarding streetlights in Edgemont area - Edgemont is a separate district and it is responsible for the streetlights, not the City; residents need to request the board to install streetlights, as the board votes and makes those decisions

#### Mayor Flickinger

1) Responded to speaker's comments about deficit situation - the City is in a deficit situation because the revenues are down; the Council has to

figure out how to provide services with less money than before

2) Responded to the comment regarding gangs in the City - the Public Safety Subcommittee had a presentation by the Police Department's Antigangs Team regarding this subject two days ago - the gangs that were previously active in the City have been shot down by the Police Department - we are tough on gangs and not allowing them to take over our city; there is no a serious gang problem in the City

3) Encouraged residents to watch American Idol on Channel 11, where Moreno Valley resident Andrew Garcia is a finalist in the national competition

4) Received a lot of e-mails supporting DUI checkpoints, which make street safer, save lives and keep citizens safe

5) The City has return only about 52 percent of the census forms; encouraged residents to return the forms to keep services funded by federal grants

6) The next round of City's foreclosure prevention workshops starts April 26 at Vista High Middle School

7) On April 22 and May 6, at 6 p.m. at City Hall, Southern California Association of Governements will be holding workshops to divise a vision document that will focus on the long-term plans for Alessandro corridor from Freeway 215 to Lasselle Street; looking for input from the public

8) Congratulated students at Moreno Valley and Riverside colleges for voting to continue free rides on RTA buses for all the students; buses are free for the next 5 years

9) Requested to agendize for next study session a discussion regarding expenditures for March Field air show and July 4th celebration; seconded by Mayor Pro Tem Hastings
