#### **RECOMMENDED ACTION**

##### **Recommendations: That the City Council:**

1. Consider the attached draft Ordinance for re-establishing a Veteran's Commission and provide staff direction and changes.

#### **SUMMARY**

A Citizen's Advisory Committee on Veteran's Affairs was established by Ordinance No. 59 adopted on February 20, 1986. The Committee served in an advisory capacity to the City Council pertaining to Veteran's affairs and dissolved in 1996. According to historical data, the committee participated in activities such as: providing representation for the Riverside County Veterans Advisory Committee, serving as a support group for the Riverside National Cemetery, Veteran's Day ceremony, Memorial Day ceremony, advocating for veterans' and their families' needs. The committee partnered with other organizations to further their cause during its existence.

#### **DISCUSSION**

The Committee's powers and duties according to Ordinance No. 59 were as outlined:

- (1) To establish and maintain open lines of communication between veterans, the City Council and City staff.
- (2) To support and cooperate with veterans' organizations in appropriate ceremonies commemorating the contributions made by military veterans in the armed conflicts in which the United States has been involved.



- (3) To encourage the maintenance of meaningful benefits for all veterans.
- (4) To acquire information and make recommendations to the City Council regarding problems and issues affecting veterans.
- (5) To serve as a veterans' support group for the Riverside National Cemetery and for March Air Force Base.
- (6) To help create public awareness of the problems facing veterans and of their needs.
- (7) To carry out such other functions as may be assigned to the Committee by the City Council.

The Committee consisted of seven (7) members who were appointed as prescribed in Sections 2.04.060 and 2.06.010 and served without compensation.

Pursuant to Ordinance No. 59, the Committee membership was to include: representation from each Veteran's organization functioning within the City; one or more persons who are or were commissioned officers in the United States Military Service, one or more persons who are or were enlisted personnel in the United States Military Service, and one or more Veterans from each of the armed conflicts in which the United States has been involved, commencing with the First World War. In the event that an insufficient number of persons from any one or more of the foregoing categories is available for appointment to the Committee, the City Council could make such substitute appointments as deemed appropriate.

The Citizen's Advisory Committee on Veteran's Affairs was dissolved in 1996 by Ordinance No. 495, due to lack of participation, which was attributed to the operation of many other active veteran organizations in the area.

Changes to the proposed ordinance establishing Veterans Commission (red line version) have been suggested by Council Members Jempson and Price.

If the Veterans Commission is re-established, provisions of the previous Ordinance should be addressed, such as eligibility requirements and the application process.

Currently, the Moreno Valley Chamber of Commerce has a strong relationship with March Air Reserve Base (MARB). The Military Affairs Committee (MAC) is an integral component that continues to foster the relationship between MARB and the Moreno Valley community. Particularly, MAC serves to support active and reserve personnel, as well as veterans.

Military Affairs Committee, composed of representatives from local businesses and government agencies, meets monthly to ensure frequent, timely communication and looks for ways to secure mutually beneficial partnerships between March Air Force Reserve Base and the community.



MAC's events and activities include:

- Fundraisers: Military Support Stickers and Rally 'Round the Flag (dinner event) – supports base personnel by providing financial assistance for various events (Picnics, Awards Banquets, the Military Ball and Military Family Day);
- Banner/ Paver Program partnership with the City. The Military Affairs Committee pays for a portion of the banners to reduce the costs for military families to \$100 per banner;
- Annual Picnic serves active and reserve personnel and their families. This is a free picnic for active military and their families allowing the community to demonstrate support and appreciation for their service and sacrifice. All donations are supplied by local community partners and operated by volunteers;
- Hangar 385 is a hospitality function that supplies deploying and returning troops with some of the “comforts of home” before their final flights to deployment destination. Hangar 385 supplies toiletries, water, PB&J sandwiches and cookies to troops while they wait for their flight; and the
- Laura Froehich Memorial Scholarship program is a competitive scholarship program providing \$500 to qualifying active and reserve duty personnel as well as veterans who are attending Moreno Valley College.

ORDINANCE NO. 59

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, AMENDING TITLE 2 OF THE MORENO VALLEY MUNICIPAL CODE BY ADDING ~~THERETO~~—A NEW CHAPTER 2.26 RE-ESTABLISHING A ~~CITIZENS ADVISORY COMMITTEE~~ ON VETERANS' COMMISSION AFFAIRS AND PRESCRIBING THE FUNCTIONS AND DUTIES THEREOF.

The City Council of the City of Moreno Valley does ordain as follows:

SECTION 1: The list of chapters prefacing Title 2 of the Moreno Valley Municipal Code is hereby amended by adding thereto "Chapter 2.26 ~~Citizens Advisory Committee on Veterans' Affairs~~Veterans Commission".

SECTION 2: Title 2 of the Moreno Valley Municipal Code is hereby further amended by inserting therein a new Chapter 2.26 reading as follows:

"Chapter 2.26

~~ON VETERANS' AFFAIRS~~

It shall consist of seven (7) members, serving without compensation, and appointed in the manner and for the terms prescribed in Sections 2.04.060 and 2.06.010, respectively of this Code, except that the terms of the members first appointed to the ~~Committee~~ Commission shall be set by lot, with three members serving through \_\_\_\_\_ ~~June 30, 1987~~, two members serving through \_\_\_\_\_ ~~June 30, 1988~~, and two remaining members serving through \_\_\_\_\_ ~~June 30, 1989~~. Thereafter, all terms shall be for three (3) years and shall expire three (3) years after the effective date of the appointment, provided, however, that the term of an appointment made to fill an unexpired term shall be for the unexpired balance of such term.

~~2.26.020~~ COMPOSITION. Insofar as practicable, the ~~Committee~~ Commission membership shall contain representation from each veterans organizations functioning within the City such as but not limited to: VFW, American Legion, and US VETS; representation from each Military branch is encouraged but not required, shall have one or more persons who are or were commissioned officers in the United States Military Service (Army, Navy, Air Force, Marines, Coast Guard), one or more persons who are or were enlisted personnel in the United States Military Service, and one or more veterans from each of the armed conflicts in which the United States has been involved, commencing with the First World War. In the event that an insufficient number of persons from any one or more of the foregoing categories is available for appointment to the ~~Committee~~ Commission, the City Council may make such substitute appointments as it deems appropriate. An adhoc Committee is encouraged.

2.26.030 POWERS AND DUTIES. (a) The ~~Committee~~ Commission shall have the general power and duty to act in an advisory capacity to the



City Council in all matters pertaining to veteran's affairs.

(b) In addition to the foregoing general power and duty, the ~~Committee~~Commission shall have the following particular powers and duties:

- (1) To establish and maintain open lines of communication between veterans, the City Council and City staff.
- (2) To support and cooperate with veterans organizations in appropriate ceremonies commemorating the contributions made by military veterans in the armed conflicts in which the United States has been involved.
- (3) To encourage the maintenance of meaningful benefits for all veterans.
- (4) A majority of the total authorized membership of the Commission shall constitute a quorum for the conduct of business.
- (5) To acquire information and make recommendations to the City Council regarding problems and issues affecting veterans.
- (6) To serve as a veterans support group for the March Air Reserve Base, Riverside National Cemetery and for the US VETS.
- (7) To help create public awareness regarding the problems facing veterans. Make recommendations for programs which develop awareness.
- (8) To carry out such other functions as may be assigned to the ~~Committee~~Commission by the City Council.

2.26.040 CHAIR, ~~COMMITTEES~~COMMISSIONS AND STAFF.  
Designation of a chairperson and vice-chairperson for the ~~Committee~~Commission shall be governed by Section 2.06.020 of this Code. The



~~Committee~~Commission may establish such standing and temporary sub-committees as it may deem expedient for the performance of its duties and the Chair-person, with the consent of the ~~Committee~~Commission, may fix and appoint the membership of such sub-committees. Except that the Chairperson of each sub-committee shall be a member of the ~~Committee~~Commission, membership on a sub-committee need not be limited to members of the ~~Committee~~Commission. The City Manager may appoint a secretary and other staff for the ~~Committee~~Commission and provide such reimbursement for their necessary expenses as may be authorized by the City Council in the City budget and approved in advance by the City Manager.

~~2.26.050~~ MEETINGS AND RULES OF PROCEDURE. The ~~Committee~~Commission shall hold one or more regular monthly meetings and designate the times, dates and places therefor. All meetings of the ~~Committee~~Commission and each of its sub-committees shall be open to the public. Special meetings may be called by the chairperson or by a majority of the ~~Committee~~Commission, provided that notice of such special meetings is given to each member of the ~~Committee~~Commission at least 48 hours prior to the time of the meeting. A majority of the total authorized membership of the Commission shall constitute a quorum for the conduct of business. The ~~Committee~~Commission shall adopt rules for the transaction of its business. The ~~Committee~~Commission shall keep a public record of its actions. Promptly after approval thereof by the ~~Committee~~Commission, minutes of ~~Committee~~Commission meetings shall be filed with the City Clerk."

2.26.040 CHAIR, COMMITTEES AND STAFF. Designation of a chairperson and vice-chairperson for the Committee shall be governed by Section 2.06.020 of this Code. The Committee may establish such standing and temporary sub-committees as it may deem expedient for the performance of its duties and the Chairperson, with the consent of the Committee, may fix and appoint the membership of such sub-committees. Except that the Chairperson of each sub-committee shall be a member of the Committee, membership on a sub-committee need not be limited to members of the Committee. The City Manager may appoint a secretary and other staff for the Committee and provide such reimbursement for



their necessary expenses as may be authorized by the City Council in the City budget and approved in advance by the City Manager.

2.26.050 MEETINGS AND RULES OF PROCEDURE. The Committee shall hold one or more regular monthly meetings and designate the times, dates and places therefor. All meetings of the Committee and each of its sub-committees shall be open to the public. Special meetings may be called by the chairperson or by a majority of the Committee, provided that notice of such special meetings is given to each member of the Committee at least 48 hours prior to the time of the meeting. A majority of the total authorized membership of the Committee shall constitute a quorum for the conduct of business. The Committee shall adopt rules for the transaction of its business. The Committee shall keep a public record of its actions. Promptly after approval thereof by the Committee, minutes of Committee meetings shall be filed with the City Clerk."

SECTION 3: Within fifteen (15) days after the adoption of this ordinance, the City Clerk shall certify to the adoption hereof and cause copies hereof, so certified, to be posted in at least four public places within the City.

SECTION 4: This ordinance shall become effective on the thirtieth day after the date of its adoption.

ORDINANCE NO. 495

An Ordinance of the City Council of the City of Moreno Valley, Deleting Chapter 2.26 of Title 2 of the City of Moreno Valley Municipal Code Relating to the Citizens' Advisory Committee on Veterans' Affairs

The City Council of the City of Moreno Valley, California, does ordain as follows:

SECTION 1. FINDINGS:

1.1 The City Council has heretofore adopted Ordinance No. 59 of the City of Moreno Valley, establishing a Citizens' Advisory Committee on Veterans' Affairs. And, due to the lack of participation on said Committee resulting from the many other active veteran organizations in the area, it is the intent of the City Council to dissolve said Committee and to remove all references to said committee within the City of Moreno Valley Municipal Code.

SECTION 2. REPEAL OF PRIOR ENACTMENTS:

2.1 Chapter 2.26 of Title 2 of the City of Moreno Valley Municipal Code is deleted in its entirety.

SECTION 3. NOTICE OF ADOPTION:

The City Clerk of the City of Moreno Valley shall certify to the adoption of this Ordinance and cause it to be posted in at least three public places in the City.

SECTION 4. EFFECTIVE DATE:

This ordinance shall be effective thirty (30) days after the date of its adoption.


