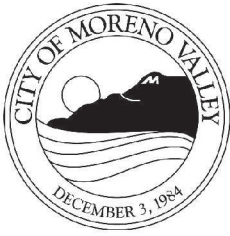

3. Select finalists to move forward to the March 24, 2015 Regular City Council Meeting.

### **SUMMARY/BACKGROUND:**

This item is to request that the City Council conduct interviews of applicants for the openings on the Planning Commission at the February 28, 2015 Special Meeting and select finalists or make appointments. There are three terms that will be expiring on March 31, 2015 and one term that is vacant due to the election of a Planning Commissioner to City Council. The Planning Commission four terms are as follows: Three (3) terms expiring March 31, 2019 and one (1) term expiring March 31, 2017.

The Planning Commission consists of seven members with four year terms. Planning Commissioners are compensated \$100.00 per meeting. The Planning Commission Meetings schedule is: Second and/or Fourth Thursday of each month at 7:00 p.m., City Hall – Council Chamber, 14177 Frederick Street.

A Notice of Openings was posted on December 9, 2014. The deadline to submit applications was January 30, 2015. The City Clerk's office received nineteen (19)

applications. All candidates were selected for an interview. One applicant declined the interview.

The Planning Commission considers matters pertaining to development and zoning within the City and has decision-making authority pursuant to the Government Code of the State of California. The appointees shall be bona fide residents of the City of Moreno Valley at the time of appointment and throughout their incumbencies.

The interview process will consist of the following:

- Each candidate has been scheduled for 20 minutes of interview time.
- Council Members may take notes as they interview the candidates.
- Discussion will take place as time permits between interviews and at the conclusion of all interviews.
- Council may narrow down the number of applicants.
- Council will forward the finalist names to the City Clerk or make appointments with terms to be decided at the March 24, 2015 Regular City Council Meeting.
