Council Member George Price recommended that the Public Safety Subcommittee serves as an ad hoc subcommittee for this, and staff, as the City Manager sees appropriate, meet and confer with the School District to resolve this issue. LaDonna Jempson made a motion that the ad hoc committee to the Public Safety Subcommittee be formed of all staff recommended as discussed: City Manager Michelle Dawson, Ahmad Ansari, Eric Lewis, and anyone else that group recommends, seconded by Mayor Jesse L. Molina. Motion carried 5-0.
